437.1 To consider consultee response to applications received from North Norfolk District Council and the Broads Authority:

437.1.1 ADV/20/2360 – Tesco Stores Ltd, Old Market Rd, Stalham, Norwich, Norfolk, NR12 9AE. 42" LCD Media Screen mounted in electric vehicle charging dock and 3 No. non-illuminated flag pole signs with overall height of 2450mm. It was AGREED to support the application.
